

LEGISLATIVE

Hi All,

Here are most of the TRS facts and figures for fiscal year 2013-2014. On some of them I have given you money figures and other numbers from previous year(s).

As you can see, we have **increased** our worth from 2012 over **3 Billion dollars** (\$3,341,943,160) or our money made **9.2%** last year !!! The previous year (2012) our money actually lost in value (down 2.5%) from 2011.

Want to see an **INCREDIBLE** figure??? In 2012, our investments made only \$224,106,719 (that's right, \$224 million). This year (2013) our total investment income was \$4,561,768,383 (that's right, \$4.5 billion). This is an increase, in ONE year, of **1,935.5%!!!** What a difference a year makes. The stock market as I write this is over 16,000 points!

In fiscal year 2013, the state of Illinois contributed \$2,703,000,000 to the TRS fund while active members and employers added another \$1,079,000,000 for a total of \$3,782,000,000.

In fiscal year 2012, the state of Illinois contributed \$2,406,000,000 to the TRS fund while active members and employers added another \$1,073,000,000 for a total of \$3,479,000,000.

In fiscal years 2014 and 2015, the state of Illinois is expected to contribute \$3,439,000,000 and \$3,413,000,000 respectively to the TRS fund. Fiscal year 2015 is actually lower than 2014 because of our fiscal year 2013 investments doing so well!! You just can't win! However, these projections may change if Senate Bill 1 is upheld by the courts.

Let's talk about unfunded liabilities. The unfunded liability in Illinois stands, right now, at 40.6%. From what I understand (in layman's terms) the unfunded liability means that if EVERY retiree went to the state of Illinois and demanded their retirement money, the state of Illinois would only be able to pay out 40.6%. This is the worst unfunded liability percentage in the United States. But, come on!!! Retirees are not going to ask for their money in a lump sum. The monthly annuity seems to work very well. However, again from what I understand, the state is governed by protection laws and Illinois has to get that ratio higher. Senate Bill 1 says that, if followed, their statutory funding plan will achieve a 90% funded ratio by the end of fiscal year 2045. This will be done, of course, by crushing retiree promises and benefits. In 2004 (only 10 years ago), Illinois' unfunded liability ratio was 61.9%. It has declined since then every year but two (2006-2007) until our present 40.6%. During the Blago regime the unfunded liability went from 61.9% to 48.4%.

Most of the TRS unfunded liability is due to insufficient state contributions since the system was established in 1939. I might add that the TRS has not missed one annuity payment during those 74 years!! Seems like the system has worked pretty well!


