SECRETARY'S REPORT

KRTA December 13, 2018 Membership Meeting Minutes



The KRTA membership Meeting was called to order by President Jim Hissong at Kennedy Pointe Restaurant, Bristol. The Pledge of Allegiance was said, and George Hayner said Grace. Jim Hissong greeted members. He expressed sympathy on behalf of KRTA to members Dorothy Simmons, Sid and Carol Simmons, wife and brother/sister-in-law of Jack Simmons who passed away on Thanksgiving Day. Jack had been a fifth-grade teacher at East View Elementary in School District 308, Oswego.

Lunch was served and after lunch Jim began the business meeting with the approval of the September 13 membership meeting minutes. Kyle Price reported the treasury balance of \$4,050.09.

Committee Reports

- **Programs:** Jan Hissong reported the Supper Club met at the Oswego Olive Garden in October. Also in October, the lunch and a movie group met at Mike and Denise's Restaurant for a half price pizza lunch. The group then saw the movie, "First Man."
- **Legislation:** Sid Simmons reported that Chicago Mayor Rahm Emanuel had announced that he supports an amendment (amendment #49) on the November 6 ballot to open the Illinois Constitution. This amendment would empower the Illinois General Assembly to modify pension benefits of public employees. If #49 would pass, it would do away with the contract protection clause. Currently, the Illinois Constitution states in Article XIII, Section 5, that "Membership in any pension or retirement system of the State, any unit of local government or school district, or an agency or instrumentality thereof shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired." 3/5 of both the House and Senate must vote yes to open the Illinois State Constitution. Sid said from what he knows many lawmakers and attorneys believe the proposal is a waste of time.

- **Community Participation:** Alimae Persons thanked the membership on behalf of the Kendall County Food Pantry for the many knitted and crocheted items donated by KRTA members today along with the \$181 collected today. Kendall County CASA will be the organization to benefit February members' donations.
- **Membership:** Randy French reported there are 178 paid members today out of 190 members. There is still time to pay your 2018-2019 dues.



- **Program:** The Yorkville High School Madrigal Singers performed a thoroughly enjoyable half hour program members that included traditional music in the Renaissance tradition. David Smith is the director of this 25 year program YHS. Jim Hissong offered the high school group and members a wise quote regarding success from Helen Keller, "The best and most beautiful things in the world cannot be seen or even touched. They must be felt with the heart." Wishing you happiness.



Jim introduced guest Chris Mehochko, Superintendent of Kendall-Grundy ROE. Mr. Mehochko said county school districts as well as the whole state are in dire need of substitutes. Please consider the possibility, he asked. Retired teachers can register even if their teaching certificates have lapsed. Teachers would be reimbursed for the cost of the fee. He also said there will be a new school funding formula this year. That process will probably drop snow days as a part of the school year.

Jim presented the 50/50 winner, Karen Baker, with her half of the winnings. The IRTA Legal Defense Fund received the second half.

Jan Hissong shared with the members interesting information about the history of toys – the table theme for today's holiday luncheon. History reveals that objects meant most likely for play date back to 500 B. C. Jan found that 1913 was when the first toy commercial appeared. And 1959 was when the first Barbie Doll was introduced much to the delight of young girls everywhere.



Most of these recipients have been retired for many years and receive very small pensions. Many do not qualify for Medicare—which is a definite financial health burden. LEGISLATIVE



Hi All,

TRS's mission is to continually deliver the retirement security promised over the last 70+ years to our 417,292 members. TRS accomplishes this mission by putting the best interests of others first, fostering diversity, embracing teamwork, and encouraging continuous improvement at all

levels. TRS investments continued to post steady growth over the long-term, exceeding its 20-year and 30-year benchmarks

TRS Fiscal Highlights

Here are some highlights for the **TRS fiscal year** that ended June 30, 2018 and were recently released by the State of Illinois.:

⇔ As in the past, TRS met its responsibilities during the 2018 fiscal year with an absolute commitment to the highest quality service to its members and their families. For instance, (1) the TRS distributed more than \$6.5 billion in retirement, disability, and survivor benefits to more than 122,000 annuitants and beneficiaries; (2) the successful delivery of TRS pensions generated a \$6.6 billion economic stimulus in every corner of the USA.



⇔ Approximately \$4.5 billion of TRS retirement benefits **stay in Illinois**, supporting more than 45,000 jobs with a payroll of \$1.9 billion;

⇔ TRS investments earned an 8.5% return, net of fees, while the 40 year average return rate stands at 9.2 percent! The system, as of June 30, 2018, has \$51.7 billion in assets.

Here are some very interesting **member** statistics:

(1) the average age for full and part-time ACTIVE (those still teaching and paying into the system) TRS members is 42 years old while the average age of those receiving a TRS annuity is 71 years old;

(2) the ACTIVE TRS member's average number of years currently teaching is 13 years! (**wow**), while the average number of years taught by a retiree is 27 years;

(3) the average annual salary of an ACTIVE TRS member is \$73,028 while the average annual annuity for a TRS retiree is \$57,312;

(4) the oldest full-time ACTIVE TRS teacher is 78 years old (!) (**wow again**) while the oldest TRS retired teacher is 107 (**no it is not me**);

(5) the total membership in TRS is 417,292 which includes active members (160,859), inactive noncontributing members (143,010), and benefit recipients (122,423).
