KRTA April 14, 2022 Membership Meeting Minutes

The KRTA membership was greeted by President Jim Hissong. The membership recited the Pledge of Allegiance. Jim then entertained members with some teacher humor. A

friend had given Jim a fun quiz meant to be taken by elementary teachers (or any grade level teacher) to identify a "true" teacher. Some of those questions were 1) Do you insist "no cuts" when you are in a checkout line and someone is squeezing ahead in the line? 2) When you speak to your auto mechanic about his service do you ask him, "Do you feel you did your best?" 3) Do you repeat everything twice to make sure they understood you?

Tom Meade led the membership in Grace. The Whitetail Restaurant staff served a delicious sit-down lunch which followed Covid 19 restrictions.

Business Meeting: The February 10, 2022 membership luncheon/meeting minutes were approved.

Committee Reports:

Treasury: Jim provided Kyle Price's report of \$4,437.21 in the KRTA treasury.

Community Participation: Alimae Persons reported that the CASA collection was \$105. They were very grateful for our donation. Today the collection of items for Tillers and Hillside Nursing Homes

will be delivered by Alimae and Jim and Jan Hissong. The collection boxes were full! Alimae thanked everyone for their generosity.

Newsletter: Janet Reardon asked that each member check their directory for errors in their information and notify the Baughmans, if so. Also, Jan said that it helps a lot in the distribution of the Newsletter if she could email the Newsletter rather than snail mail it. She asked members who have not provided their email address to her to please do so.

Communication: Sue Matile and Judy Burkhard thanked the luncheon callers for their fine work.

Program: Jan Hissong reported she will try to hold a Lunch and a Movie in May in Yorkville. Lunch will be at Mike and Denise's Restaurant when there is a good movie at the theater.

Legislation: Sid Simmons reported TRS and TRIP information. By the end of December 2021, TRS investments were at an all-time high of \$66 billion; the investments had earned 16.8%. Last year, TRS paid out \$7.4 billion in benefits to its members. TRS will divest money from Russian companies. The information about the Benefit Choice Period will be mailed to retirees currently enrolled in TRIP by the end of April or early May. If members do not want to change their coverage, they do not have to do anything. The Illinois General Assembly passed a budget that was signed by Governor Pritzker. TRS members can now teach 140 days with no penalty.

Program

Jim introduced IRTA AMBA benefits representative, Nancy Cramer. Nancy presented a well-defined update of the approximately 26 benefits KRTA members can choose to participate in when they are also IRTA members. Some of the benefits include long term care, recovery care, a cancer, heart attack, and stroke program, dental and vision program, and travel discounts.



Tom Meade then introduced the musical entertainment for the day, Good Clean Fun. The exciting duo sang a medley of well-loved songs from the 60's and 70's. They concluded with everyone's favorite, "Sweet Caroline," by Neil Diamond.

Jim conducted the 50/50 raffle with the usual good humor. The winner split the wins with the IRTA Legal Defense Fund.

In conclusion, Jan Hissong shared with members some insightful thinking on how and why we should appreciate the small things in life.



The next KRTA membership luncheon and meeting will be held at Whitetail Ridge Golf Club on June 9, at noon.

Jim Hissong adjourned the meeting.

LEGISLATIVE

Illinois Policy Institute

There is a force looming over our heads called the Illinois Policy Institute (IPI) that wants to silence worker's voices and rob us of our Teacher Retirement System (TRS) security. It's time someone steps up and fires back at this organization whose sole goal is to get members

to quit their union and to make retiree organizations as weak as possible.

The IPI is using mailers, phone calls, videos, emails and even home visits to try and convince members to "opt out" of their union. The IPI shows little interest in anything else in the world except taking down public employee unions which includes the Illinois Education Association and the state pension system. They don't care that the TRS is protected by the State Constitution and that public educators worked for 20-35 years to build a secure pension and retirement program. The IPI just wants to destroy the IRTA and any local retirement association like the KRTA which is the only source of organized power for retirees in our state. When I started teaching in 1965, I made \$5,200/year, had no (zero) insurance benefits, and had no (zero) negotiation abilities!! We, as teachers, have come a long way baby.

Teacher union members need to "wake up" and stand up to the Illinois Policy Institute. Current teacher union members need to double down to defend the rights and benefits that we retirees worked so hard to obtain when we stood together for so many decades.

Why is the IPI so committed to weakening public employee unions? Because they want to abolish public employee pensions. They know that strong unions are the chief force standing in their way. If they can weaken us, their odds of ending pensions would go way up.

And now there is another vigilante group surfacing in California called the Freedom Foundation that is a clone of the IPI. After this November election is completed, the IRTA, the TRS and local organizations will once again have to "stand guard" and protect our pensions and insurance policies. As Patrick Henry said, "United we stand, divided we fall".....
