Business Meeting
Minutes from the February 9, 2023, KRTA luncheon meeting were approved as read.

## Committee Reports

Legislation: Sid Simmons told members that Governor Pritzker has allocated \$200 million to go to 170 Illinois school districts that desperately need funds to hire district substitutes and classroom teachers of designated grade level curriculum. He then reported on legislation he had previously reported at the February KRTA luncheon meeting because of its importance to many members. The Illinois legislators are seeking to repeal the Social Security Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) this year. The Social Security Fairness Act of 2023 - HR82 was introduced in January 2023. The IRTA encourages members to contact their representatives to support this bill. Another bill that has been introduced in the Illinois Senate (SB 1749) would add vision and dental insurance coverage to the basic Aetna health insurance plan. Sid urged members to contact their Illinois Senator and House Representative to encourage them to support this bill.

Programs: Jan Hissong said there will be a Lunch and a Movie next Wednesday, April 19. Lunch will be at Dearborn Restaurant and the movie is "AIR". Both venues are in Yorkville.
Communication: Sue Matile thanked the callers for obtaining the number of members attending the KRTA luncheons. The accuracy helps Whitetail Restaurant provide adequate servings for the attendees.

Community Participation: Alimae Persons thanked members for the generous donations received today for Tillers and Hillside Nursing Homes. The collection at the June 8 membership luncheon meeting will be for the Kendall County Food Pantry school supplies.
Membership: Sharon Pagoria reported that there are 137 paid KRTA members. There are 65 members who have paid for the next year, 2023 - 2024. Sharon said there are 13 members who have not paid for 2022 - 2023. As stated in the April Newsletter, if the current year's dues of $\$ 20$ is not paid by April $30^{\text {th }}$, 2023, the member will be taken off the KRTA Membership Roster and will no longer receive the Newsletter and KRTA Membership Directory.
Treasurer: There was no report.
Directory: Bob Baughman reported the new inserts for the 2022 Directories are on the luncheon tables for members to take for themselves and for anyone they know who is not in attendance today.

## LEGISLATIVE

Illinois legislators did not finish their Spring session by Friday's May 19 scheduled adjournment as negotiations over the state budget remain in flux. Per the Illinois Constitution, legislators have until May 31 to pass a budget for the coming fiscal year with simple majorities. The next fiscal year begins July 1.
Legislative leaders in the General Assembly announced that they would return on Wednesday, May 24 and Thursday. The House has scheduled a Friday, May 26 session as well.
Both the IL House and Senate have Democratic super majorities.
While rank-and-file lawmakers awaited the budget details Friday the 19th, several other major initiatives were filed in last minute fashion. That included an expansive cannabis regulatory bill, a change to IL biometric privacy law, a broad elections bill and an ethics proposal prohibiting political donations from red light camera companies.

* CANNABIS: this bill aims to implement a variety of reforms to the IL cannabis industry that would change dispensary operations and restrictions on craft growers.
* BIOMETRIC PRIVACY: this bill would change IL Biometric Information Privacy Act and allow individuals to sue companies over improper collection or storage of information such as fingerprints or facial scans.
* ELECTIONS: this bill would establish a task force to study the feasibility of adopting a ranked choice voting system in certain elections. That's a method of voting in which voters can mark their ballot for multiple candidates in order of their preference.
OTHER ACTION: Other bills were introduced on the 19th that saw the passage of several other measures. Those include bills allowing optional all-gender bathrooms, regulating the gun industry, environmental measures, and dozens of others.


## Breaking News-Hot Off The Press!

Two pension-related measures have just been introduced to the General Assembly. Illinois lawmakers will have to wait for the next legislative session to address these bills, but I wanted to give everyone a 'heads-up.'
House Bill 4098 would discontinue the General Assembly Retirement System (GARS), the worst funded of the state's five retirement systems, as well as the Judges' Retirement System and would allow for future members to be offered enrollment into the existing State Employees' Retirement System (SERS). As I see it, this change should not impact the TRS but ... ? Something to keep an eye on.
House Bill 4099 would adjust the pension age for individuals who provide various security duties for the state of Illinois.
