LEGISLATIVE

Illinois House and Senate members returned to Springfield May 19 and are scheduled to work straight through to next Saturday, May 31. A staggering 73 budget bills, exceeding \$37,000,000,000, were brought to the House floor for a vote during an 11 hour marathon. Since that total amount exceeded Illinois' projected income by over \$3,000,000,000, the only Representatives who voted yes were the same folks who knew they'd also be voting to make the temporary income tax permanent for Illinois taxpayers. Now those bills must go to the Senate for approval or amendment.

The 2013 pension reform law still has not been enacted. Last week a court put an injunction hold on the implementation pending other legal action. Those pension commitments now exceed \$100,000,000,000 and continue to grow. Illinois' credit rating has been downgraded five times just since the tax increase was implemented.

Budget Details: Here's a brief snapshot of the Illinois General Revenue Fund (GRF) budget. Remember, this budget requires a permanent income tax increase *General*

- Makes the certified FY15 pension payment of \$6.045 billion.
- Moves \$197 million from unclaimed property sales for pension payment.
- Group Insurance receives \$1.475 billion.

K-12 Education

- General State Aid increases \$132 million, proration level set at 90%.
- Regular/Vocational Transportation increases by \$54 million, prorated at 83%.
- Early Childhood Education increases \$25 million.
- Bilingual Education increases by \$12.3 million.
- Higher Education
 - Universities generally receive flat funding.
 - MAP grants receive an increase of \$51.55 million.
 - Illinois Math Science Academy (IMSA) budget decreases \$1.8 million, to encourage diversity commitment. Of the Academy's 650 students, the majority are Caucasian and Asian. Less than 150 are African American or Hispanic.
 - \$465,500 for Veterans' Grants reimbursements at specified colleges.

Human Services

- Medicaid generally based on Governor's recommended funding level.
- Veterans' Affairs increases \$9 million for required nursing home staffing ratios.
- Children and Family Services increases include \$1.9 million for Foster Care, \$5 million for Family Preservation, \$1 million for Adoption and Guardianship.
- Poison Control Center receives \$2 million. Public Health receives \$1 million for new Hepatitis Outreach program.
- Community Care Program at Aging increases \$111 million.
- Human Services Fund includes \$40 million for operations, \$45 million for child care grants, \$21 Million for Home Services.
- \$5.6 million Chicago Area Project grant for delinquency prevention.

Public Safety

- State Police increases \$28.5 million. Adds third cadet class (Two at State Police, One at State Police Merit Board).
- Corrections includes \$9 million to reopen Murphysboro facility as DUI facility and begin the process of opening the former Joliet Youth facility as facility for incarcerated individuals.

Legislation of Note: Senate Bill 219 would create the "Go for the Gold" instant scratch-off game within the Illinois State Lottery for Special Olympics and Special Children's Charities. Special Olympics Illinois will receive 75% of the revenues to support statewide training, competitions, and programs for future Special Olympics athletes. Special Children's Charities will receive 25% of the revenues to support the City of Chicago training, competitions and programs for future Special Olympics athletes.
